ARTICLE I - NAME AND ADDRESS

The name of this corporation is Florida Professional Billing Service, ^{Inc.} The address of the principal office and the mailing address of this corporation is 7355 SW 118 court Miami, Fl 33183.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE III - CAPITAL STOCK

The aggregate number of shares which this corporation shall have authority to issue is One Thousand (1,000) shares of common stock, all of which are to have a par value of One Cent (\$.01) per share. 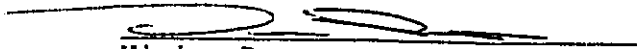
