## ARTICLES OF INCORPORATION OF CHANNEL 26 OF DAYTON, INC.

The undersigned, acting as incorporator of Channel 26 of Dayton, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

#### ARTICLE I. NAME
