After talking with my partner yesterday. I asked about business & she informed me a vendor said our corporation was "administratively dissolved" (during a credit check). We never intentionally wanted to be dissolved. We have been operating as a corp. for over 5 years and it appears the attorney who set up our corp. was our agent who moved & never informed us. The State of FL should have gotten \$150 per year for 1998, 1999, & 2000. Enclosed is our check for \$450. The post office never sent the reports to us directly as they probably returned undeliverable and returned to State of FL. I went over to the Post Office and the postal clerk said that the policy is to send back to the state. We are very sorry & embarrassed by this whole matter. Will you please abate the reinstatement penalties. I will be listed as an officer & director & registered agent so this will not happen again.
