ARTICLES OF INCORPORATION

OF

The undersigned subscriber(s) to these Articles of Incorporation, natural person(s) competent to contract, do hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I NAME

The name of this corporation is W. AKER, INC.

ARTICLE II PRINCIPAL OFFICE

The address of the principal office of this corporation is U.S. 19 S., Lamont, Florida 32336; and the mailing address of this corporation is Rt. 1, Box 166-A, Lamont, FL 32336.

ARTICLE III BUSINESS PURPOSE

The general nature of the business or businesses to be transacted by this corporation is:

- (a) to engage in any activity or business permitted under the laws of the United States and the State of Florida, and
