corporation shall not be subject to court-ordered indemnification pursuant to Section 607.0850(9), Florida Statutes.

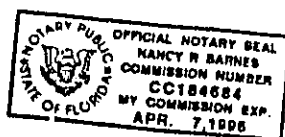
