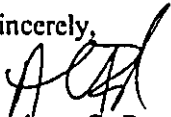

ARTICLES OF INCORPORATION
OF
VICENTE A. CHAVARRIA, M.D., P.A.

The undersigned, acting as incorporator of VICENTE A. CHAVARRIA, M.D., P.A., a Professional Service Corporation under the Florida Professional Service Corporation Act in conjunction with the General Corporation Act, adopts the following Articles of Incorporation:

1. The name of the corporation shall be as stated above.
2. The period of duration is perpetual.
3. The purpose of the corporation shall be to engage in the providing of medical services to the general public, and to invest and conduct such other investment activities as may be permitted by the laws of the State of Florida and the United States.
4. The capital stock of the corporation authorized, the par value thereof, and the characteristics of such stock shall be as follows: 10,000 shares at \$1.00 par value.

All of such stock shall be payable in cash or other valuable property, real or personal, tangible or intangible, or in labor or services actually performed for the said corporation, at a just valuation to be fixed by the Board of Directors of the corporation. No person, who is not a Medical Doctor, or an established Professional Service Corporation who is engaged in the business of providing medical services, shall be allowed to own the corporate stock of this company.

5. The corporation shall be deemed to exist as a valid corporation under the Laws of the State of Florida on the date in which the Articles of Incorporation are filed in the office of the Secretary of State.

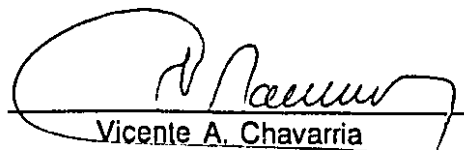
6. The initial principal place of business of the corporation shall be located at: 7400 N. Kendall Dr., Suite 104, Miami, Fl. 33156.

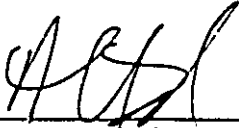

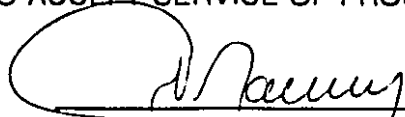
