#### ARTICLE I NAME

The name of the Corporation is: GRIZZLE LAWN SERVICE, INC., a domestic corporation which is not a member of any affiliated group.

## ARTICLE II PRINCIPAL OFFICE

## ARTICLE III PURPOSE

The general purposes for which the Corporation is organized are:

- 1. To engage in the business of lawn care. Such activities shall include, but not be limited to, lawn mowing, scrubbery maintenance and any and all overall lawn care services.
