ARTICLE I
NAME

The name of the Corporation is: GRIZZLE LAWN SERVICE, INC., a domestic corporation which is not a member of any affiliated group.

ARTICLE II
PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 20233 Keene Road, Lithia, FL 33547.

ARTICLE III
PURPOSE

The general purposes for which the Corporation is organized are:

1. To engage in the business of lawn care. Such activities shall include, but not be limited to, lawn mowing, scrubbery maintenance and any and all overall lawn care services.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
3. To do such other things as are incidental to the foregoing or necessary in order to accomplish the foregoing.

ARTICLE IV CAPITAL STOCK

The aggregate number of shares which the Corporation is authorized to issue is One Hundred (100). Such shares shall be of one class, and shall have a par value of One Dollar (\$1.00) per share. All issued stock shall be held of record by not more than five (5) shareholders. Stock will be issued and transferred only to natural persons for money and other property.

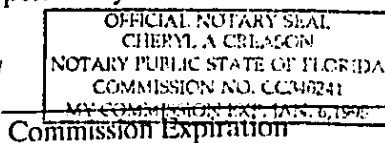
