ARTICLE I  
NAME

The name of the Corporation is: WABASH TRAILERS OF FLORIDA, INC., a domestic corporation which is not a member of any affiliated group.

ARTICLE II  
PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 6305 Marbella Blvd., Apollo Beach, FL 33572.

ARTICLE III  
PURPOSE

The general purposes for which the Corporation is organized are:



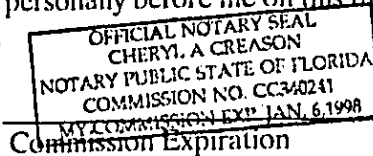
