ARTICLE I - NAME

ARTICLE IV - CAPITAL STOCK

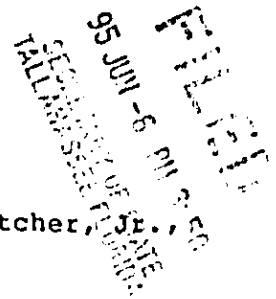
This corporation is authorized to issue 100 shares of
