**ARTICLES OF INCORPORATION
OF**

AFFORDABLE DRIVERS, INC.

THE undersigned subscriber of these Articles of Incorporation, a natural person competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be AFFORDABLE DRIVERS, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence, commencing May 25, 1995.
