ARTICLES OF INCORPORATION

FILED 95 JUN -6 AH 8: 52

The undersigned Incorporator, for purposes of formilities, a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is FunJet Airlines, Inc. (the "Corporation").

ARTICLE II

The principal office address is 8090 Twin Lake Drive, Boca Raton, Florida 33496.

ARTICLE III

JUN - 1 1995

The Corporation is authorized to issue ten million (10,000,000) shares of common stock, par value \$.01 (one cent) per share.

ARTICLE IV

The street address of the initial registered office of the Corporation is 1515 S.E. 17th Street, Suite 101, Ft. Lauderdale, Florida, 33316, and the registered agent at that address is A. Wayne Lackey.

ARTICLE V

The name and address of the Incorporator of the Corporation is A. Wayne Lackey, 8090 Twin Lake Drive, Boca Raton, Florida, 33496.

ARTICLE VI

The Corporation is organized for the purpose of transacting any and all lawful activities or business for which corporations may be formed under Chapter 607 of Florida Statues.

ARTICLE VII

The Corporation shall have one director initially and the number of directors may be increased or diminished from time to time as provided in the Bylaws, but shall never be less than one. The Corporation expressly elects not to be governed by Section 607.0901 of the Florida Business Corporation Act, as amended from time to time, relating to affiliated transactions.

The Corporation expressly elects not to be governed by Section 607.0902 of the Florida Business Corporation Act, as amended from time to time, relating to control share acquisitions.

ARTICLE X

The corporate existence of the Corporation shall commence on June 1, 1995.
