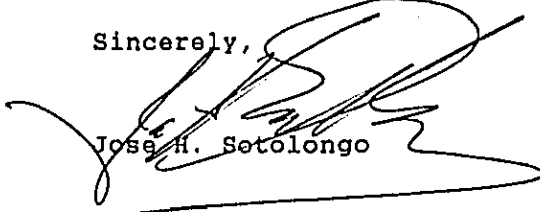

The undersigned natural person acting as incorporator of a corporation under the provisions of the Florida General Corporation Act, hereby adopts the following ARTICLES OF INCORPORATION:

ARTICLE I
NAME OF THE CORPORATION

The name of the Corporation is: "J.H.S., INC."

ARTICLE II
DURATION

The period of duration of the Corporation is: PERPETUAL.

ARTICLE III
NATURE OF BUSINESS

The purpose of this corporation is to engage for profit in the transaction of any and all business permitted under the laws of the United States and the State of Florida.

ARTICLE IV
CAPITAL

The Corporation shall have authority to issue and have outstanding not more than TEN THOUSAND (10,000) shares of common stock, each having a par value of ONE DOLLAR.

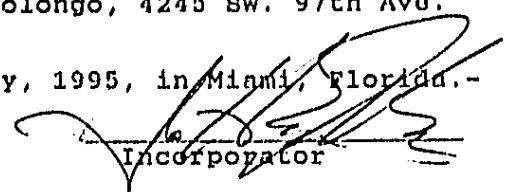

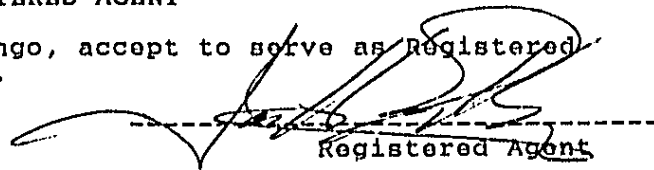

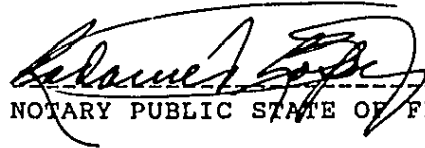
