ARTICLES OF INCORPORATION

OF

HOME VIEWING SERVICES, INC.

ARTICLE I - NAME AND PRINCIPAL LOCATION

The name of this corporation is "Home Viewing Services, Inc.". The principal location of the corporation is 450 Live Oak Avenue, Chuluota, Florida 32766.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of providing computer program services for real estate companies and engaging in any act, duties or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue One Thousand Five Hundred (1,500) shares of common class, at One Dollar (\$1.00) par value.

ARTICLE V - CAPITAL STRUCTURE: Subchapter S Corporation

This corporation shall have all the corporate powers enumerated in the Florida General Corporation Act.


ARTICLE X - INDEMNIFICATION

This corporation shall indemnify any officer or any former officer to the full extent permitted by Law.


ARTICLE XI - AMENDMENT


