The undersigned Incorporator subscribing to these Articles of Incorporation, being competent to contract, hereby forms a Corporation under the Laws of the State of Florida.

ARTICLE I

The name of this Corporation shall be: **NEJA TELECOMMUNICATIONS COMPANY**, and its initial mailing address and principal office address shall be: 10018 46th Ave. W., Bradenton, Florida 34210.

ARTICLE II

The purpose of this Corporation is to engage in any and all business not prohibited by the Laws of the State of Florida.


These Articles of Incorporation may be amended in the manner provided by law.
