ARTICLES OF INCORPORATION

RAFCO, INC.

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the Corporation is RAFCO, INC.

ARTICLE II DURATION

The term of existence of the Corporation is perpetual.

ARTICLE III PURPOSE

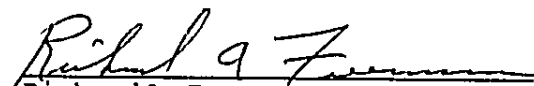

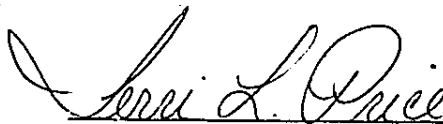
