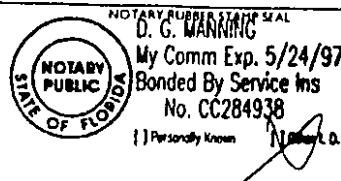

Dear Ms. Mortham:

This is to inform you that I have decided to dissolve VALPAWASH, Inc. effective immediately.

This Company was created with a specific purpose which was to provide services of Valet Parking and Hand Car Washing within the SAWGRASS MILLS MALL located at Sunrise in Broward County.

After we had reached an Agreement with the Management of Sawgrass Mills Mall, we requested the necessary License to start the aforementioned operation, we were informed at that time that the City Ordinance prohibited the washing of vehicles outside of a building. Although we argued that there are hundreds of vehicle owners and independent Car Detailing Companies washing vehicles outside of buildings, we were not able to obtain approval.

We kept the Company alive, in paper, hoping that we could eventually obtain the license, since this has not been possible, there is no reason for the Company to exist and we therefore wish to terminate it officially.

Consequently, we will not file the 1997 Corporation Annual Report Document # P95000043805 (7) for VALPAWASH, Inc. FEIN 65-0592426.


