The undersigned, being a Registered Nurse and being duly certified to engage in the practice of Nursing in the State of Florida, adopts the following articles of incorporation for the purpose of forming a professional service corporation for profit in accordance with the laws of the State of Florida and Florida Statutes Chapter 621:

#### ARTICLE I-NAME

The name of this corporation shall be;

### **ARTICLE H - DURATION**

The corporation shall have a perpetual existence and shall begin Five days prior to the date these Articles of Incorporation are filed with the Department of the State of Florida.
