ARTICLES OF INCOMPORATION



The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do heraby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is

Britannia Fine Poods Corp.

ARTICLE TWO

The duratio. of the corporation is perpetual.

ARTICLE THREB

The general purposes for which the corporation is organised are:

- 1. To engage in the business of Import & Export
- 2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.
- 3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
