**ARTICLES OF INCORPORATION**

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

**ARTICLE I**

The name of the corporation is P & T Sod, Inc.

**ARTICLE II**

The period of its duration is perpetual.

**ARTICLE III**  
**Commencement of Corporate Existence**

The corporate existence of P & T Sod, Inc. shall commence upon the date of the subscription and acknowledgment of these Articles of Incorporation pursuant to Florida Statute 607.167(1).

**ARTICLE IV**  
**Purpose**

The purpose or purposes for which P & T Sod, Inc. is organized are to engage in a general business and to do everything necessary, proper, advisable, or convenient for the accomplishment of said purposes, and to do all other things incidental to them or connected with them that are not forbidden by the Florida Corporation Laws or by any other law, or by these Articles of Incorporation, and to carry out the said purposes in any state, territory, district or possession of the United States, or any foreign country, to the extent that these purposes are not forbidden by the law of the state, territory, district or possession of the United States, or by the foreign country.

**ARTICLE V**  
**Authorized Shares**

The aggregate number of shares that the corporation shall have the authority to issue is 7500 shares of capital stock with the par value of \$1.00.

**ARTICLE VI**

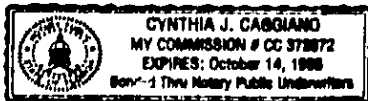
