ARTICLES OF INCORPORATION

OF

JUST INAGINE, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. MAME

The name of the corporation shall be: JUST IMAGINE, INC. The principal place of business shall be 1924 Chesapeake Court, Oldsmar, Florida 34677, Pinellas County.

ARTICLE II. MATURE OF BUSINESS

This corporation is formed to act, without limitation, as booking agent, broker, and promoter of and for dancers and other entertainers, who are independent contractors. This corporation may additionally engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have at any one time is 10,000 shares of common stock having a par value of \$1.00 per share.

ARTICLE IV. ADDRESS
