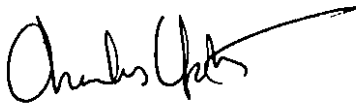

The undersigned incorporator delivers these Articles Of Incorporation in order to form a corporation under the Florida General Corporation Act.

ARTICLE I
NAME AND PRINCIPAL PLACE OF BUSINESS

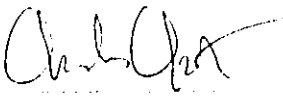
