**ARTICLES OF INCORPORATION  
OF  
AHAS, INC.**

**Article I - Name**

The name of this corporation is **AHAS, INC.**

**Article II - Duration**

This corporation shall exist perpetually.

**Article III - Purpose**

The purpose for which the corporation is organized is to engage in the transaction of any or all lawful business, including, but not limited to, purchasing and selling of retail and wholesale goods and products to the public, and any and all related activities for which corporations may be incorporated under the provisions of the Florida General Corporation Act.

**Article IV - Capital Stock**

Every stockholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that at which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others. The number of authorized shares shall be 7,500 shares at \$1.00 par value.

**Article V - Registered Agent**

The street address of the initial registered office of this corporation is 501 Oak Haven Drive, Altamonte Springs, Florida 32701, and the name of the initial registered agent and officer of this corporation is **RONALD W. BLACK**, of 112 South Lake Avenue, Orlando, Florida 32801.
