ARTICLE I. NAME.

The name of the corporation is and shall be Betty Ann Florist.

ARTICLE II. DURATION.

The period of duration of the corporation shall be and is hereby declared to be perpetual.

ARTICLE III. PURPOSE.

The purpose of the corporation shall be to engage in the business of doing any activities or businesses permitted under the laws of the United States and the State of Florida.

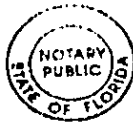
