The undersigned subscriber to these Articles of Incorporation, hereby forms a corporation under the laws of the State of Florida.

# ARTICLE I

#### NAME

The name of the corporation is BIANCA DOLLS, INC.

#### ARTICLE II

# PRINCIPAL OFFICE AND MAILING ADDRESS
