ARTICLES OF INCORPORATION

OF

WORK UNIFORMS, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this Corporation is: Work Uniforms, In

ARTICLE II

The duration of the Corporation is perpetual.

ARTICLE III

The general purposes for which the Corporation is organized are:

- 1. Buy, sell, auction, lease, trade, broker, exchange and any other legal business activities necessary to operate a business for the sale of uniforms, wholesale and retail.
- 2. Lease or purchase of equipment, enter contracts, advertising, marketing, promotion, bank and borrow money, ..ire employees and any other acts reasonably necessary to operate a business for the sale of uniforms.
