ARTICLES OF INCORPORATION

OF

A-QUALITY POOL SERVICE, INC.

ARTICLE I. CORPORATE NAME

The name of the Corporation is **A-QUALITY POOL SERVICE, INC.**

ARTICLE II. DURATION

The Corporation shall have perpetual existence.

ARTICLE III. PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation is **2905 Dewey Street, Tampa, Florida 33607.**

ARTICLE IV. CAPITAL STOCK

The total number of shares which the Corporation shall have authority to issue is **Five Hundred (500) shares of common stock with a par value of One Dollar (\$1.00) per share.**
