#### ARTICLE I. CORPORATE NAME

The name of the Corporation is A-QUALITY POOL

INC.

## ARTICLE II. DURATION

The Corporation shall have perpetual existence.

### ARTICLE III. PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation is 2905 Dewey Street, Tampa, Florida 33607.

## ARTICLE IV. CAPITAL STOCK

The total number of shares which the Corporation shall have authority to issue is Five Hundred (500) shares of common stock with a par value of One Dollar (\$1.00) per share.
