ARTICLES OF INCORPORATION OF

VERO DISPERSION MACHINES, INC.

Article 1. Name.

The name of the Corporation is: VERO DISPERSION MACHINES, INC..

Article 2. Duration

The duration of the Corporation is perpetual.

Article 3. Purpose.

The general purposes for which the Corporation is organized are the following:

- a. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- b. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

Article 4. Capital Stock.

The total number of shares of capital stock that the Corporation shall have authority to issue is 1,000, all of which are to be common stock with a par value of \$.10.

Article 5. Initial Registered Office and Agent.

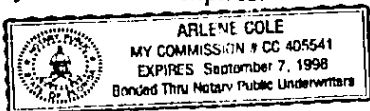


