As per our conversation earlier today, I am writing to you in regards to the reinstatement of my corporation named SANGIV I PATEL DDS, PA. I was made aware of the dissolved status today via First Union Banks while in the process of completing closing documents on a new office. According to my understanding the corporation was dissolved because there has not been an annual profit corporation report filed since 3/13/96.

The reason that 1997 and 1998 profit corporation annual reports were not filed was due to an error on your behalf on the mailing address. It seems that the requests for the reports were sent to an old address that is not accurate. I am enclosing copies of the 1996 report along with a letter of confirmation from the IRS as requested proof that we did try to comply with change of address notices in 1995 and 1996. We have never received requests in 1997 and 1998 for annual reports. If the requests would have been received, I assure you that a timely compliant filing would have occurred.

I have enclosed a check in the amount of \$315.00 per your request, \$165.00 for 1997 annual fees and \$150.00 for 1998 annual fees. I also have a confirmed closing date on my new office for Tuesday May 19, 1998, which is now contingent upon the reinstatement of the corporation prior in order to process the loan. The future of my practice is at stake in this timely matter. I sincerely appreciate all of your efforts in helping me to resolve this unrealized error. Thank you.
