### ARTICLES OF INCORPORATION OF

PROFESSIONAL LEGAL SERVICE CORPORATION UNDER F.S. 621

#### ARTICLE I. CORPORATE NAME AND PURPOSE.

The name of this professional legal service corporation is JAMES J. LOW III & ASSOCIATES, P.A., and its purpose is to practice law.

#### ARTICLE II. PRINCIPAL OFFICE.

The principal place of business for the practice of law and mailing address of this professional service corporation are Post Office Box 506, Clearwater, Florida 34617.

#### ARTICLE III. CAPITAL STOCK.

The corporation shall have three classes of stock to be distinguished as Class A, B, and C stock. The number of shares of Class B stock that this corporation is authorized to have outstanding at any one time is one thousand (1000) with a par value of one dollar each. Each class shall have limitations and relative rights, to wit:

Class A: This class of stock shall have exclusive voting rights and will not participate in dividends or asset distribution. There shall be three (3) shares authorized to be outstanding at any one time. The par value of Class A stock shall be one dollar each.

Class B: This class of stock shall not have any voting rights whatsoever, but shall have exclusive rights to the dividends and asset distributions made by the corporation. The number of shares of Class B stock that this FS § 621 corporation is authorized to have outstanding at any one time is one thousand (1000) with a par value of one dollar each.

Class C: This class of stock shall not have any voting rights whatsoever and will not participate in dividends or asset distributions, but the holder of this class may practice law, pursuant to FS § 621,09 as a stockholder of this corporation. There shall be ten (10) shares authorized to be outstanding at any one time. The par value of Class C stock shall be one dollar each.

#### ARTICLE IV. INITIAL REGISTERED AGENT AND OFFICE.

The name and address of the initial registered agent are William C. Borgersen, Esquire, 2530 West Bay Drive, Largo, Florida 34640.

#### ARTICLE V. INCORPORATORS.

#### ARTICLE X. INDEMNIFICATION OF DIRECTORS AND OFFICERS.
