**ARTICLES OF INCORPORATION
OF
GONE CAMPING RV SALES, INC.**

The undersigned subscriber to these Articles of Incorporation, desiring to form a corporation under the laws of the State of Florida, does hereby accept all of the rights and privileges, benefits and obligation conferred and imposed by said laws and does hereby adopt the following Articles of Incorporation as the Charter of the Corporation hereby organized.

ARTICLE I — NAME

The name of the Corporation shall be **Gone Camping RV Sales, Inc.**

ARTICLE II — DURATION

The Corporation shall have a perpetual existence.

ARTICLE III — PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV — CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is one million (1,000,000) shares of common stock having a par value of \$0.01 per share.

ARTICLE V — INITIAL REGISTERED OFFICE AND AGENTS

The initial registered office of this Corporation shall be 6939B Hacham Drive, Port Richey, Florida 34668, and the initial registered agent of this Corporation shall be Anthony Palarino, at that office, who, upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes as amended from time to time, with respect to keeping an office open for service of process.

ARTICLE VI -- INITIAL BOARD OF DIRECTORS

The initial Board of Directors shall consist of one member. The number of directors may be increased or decreased from time to time by vote of the stockholders, but in no case shall the number of directors be less than one. 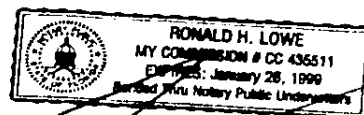
