OF

ARTICLE I - NAME

The name of this Corporation is Southern Exposure Satellite Communications, Inc.

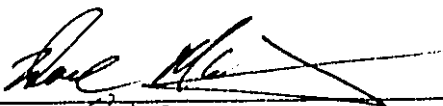

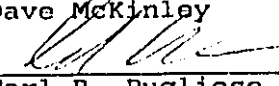
ARTICLE XI - AMENDMENT
