KNOW ALL MEN BY THESE PRESENTS: That the undersigned incorporators have associated themselves together, and do certify that they associate themselves together for the purpose of forming a body corporate under and by virtue of Chapter 607, Florida Statutes 1985, for the transaction of business with and under the following charter:

#### ARTICLE VIII - DIRECTORS

The initial number of directors of this corporation shall be two (2), and may be increased or diminished from time to time in accordance with the By-Laws of this corporation.

Directors, as such, shall receive such compensation for their services, if any, as may be set by the board of directors at any annual or special meeting thereof. The board of directors may authorize and require the payment of reasonable expenses incurred by directors in attending meetings of the board of directors.

The annual meeting of the stockholders shall be held at the time and place which shall be set forth in the By-Laws of the corporation.

#### ARTICLE IX- MISCELLANEOUS

The Board of Directors shall have the full power and authority to fix the price for, and to fix limitations upon, the issuance of all stock certificates and for the sale of all stock. Meetings of the stockholders and meetings of the Board of Directors of this corporation may be held within or without the State of Florida.
