ARTICLE I

The name of the corporation is MOMENTUM, INC. (the "Corporation").

ARTICLE II

The effective date of these Articles of Incorporation shall be June 15, 1995

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

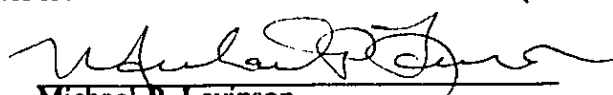
This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by law in existence either now or hereafter.
