NAME

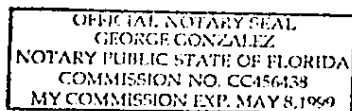

