

Pursuant to the provision of the Florida Business Corporation Act, the following Articles of Merger are hereby adopted for the purpose of merging a wholly owned subsidiary corporation, ATNC Inc., a Florida corporation ( the "Subsidiary Corporation"), into its parent corporation, American Network Systems Inc., a Florida corporation (the "Surviving Corporation"):

1. The Plan of Merger is attached hereto and made a part hereof as Exhibit "A".
2. There are 1,000 outstanding shares of common stock of the Subsidiary Corporation, all of which are owned by the Surviving Corporation.

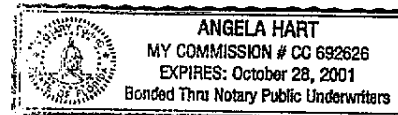

**PLAN OF MERGER OF  
ATNC INC.  
INTO  
AMERICAN NETWORK SYSTEMS INC.**

Pursuant to the provisions of the Florida Business Corporation Act, the following shall serve as the Plan of Merger of ATNC Inc., a Florida corporation, into American Network Systems Inc., a Florida corporation:

1. The name of the subsidiary corporation is ATNC Inc. The name of the parent corporation is American Network Systems Inc.
2. American Network Systems Inc. owns 100% of the outstanding shares of ATNC Inc. and shall be the surviving corporation.
3. All outstanding shares of ATNC Inc. shall be canceled upon the merger.
