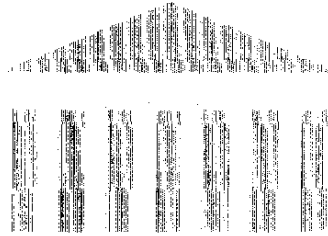


Dear Ms. Sellers:
