ARTICLES OF INCORPORATION

OF

MARK'S LAWN AND LANDSCAPING, INC.

The undersigned subscriber, a natural person acting as Incorporator for the pullbases of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE NAM

The name of the Corporation shall be MARK'S LAWN AND LANDSCAPING, INC.

ARTICLE TWO DURATION

The term of existence of the Corporation shall be perpetual and it shall commence on June 1, 1995.

ARTICLE THREE PURPOSE
