ARTICLES OF INCORPORATION
OF
SONLIGHT INDUSTRIES, INC.

ARTICLE I
NAME

The name of this corporation is SONLIGHT INDUSTRIES, INC.

ARTICLE II
TERM OF CORPORATE EXISTENCE

This corporation shall exist perpetually unless dissolved according to law and such existence shall commence at the time of filing of these Articles of Incorporation by the Department of State.

ARTICLE III
AUTHORIZED SHARES

The Aggregate number of shares which the Corporation shall have the authority to issue is 1,000 shares of Common Stock with a \$1.00 per value per share. It is intended that stock issued by this corporation shall be in accordance with Section 1244 of the Internal Revenue Code of 1954 as amended.

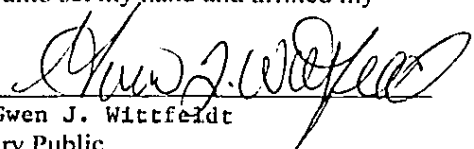

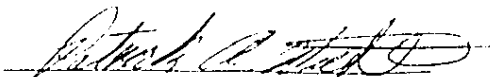
