ARTICLES OF INCORPORATION

OF

ARTICLE I

Name. The name of this corporation is VOICE QUEST, INC.

ARTICLE II

Duration. The corporation shall be perpetual.

ARTICLE III

<u>Purpose.</u> This corporation is organized for the purpose of transacting any or all lawful business.
