THE ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under Florida Chapter 607 Corporation Act, adopts the following Articles of Incorporation for such corporation:

D NAME:

The name of the corporation is: TECHNO-2000, INC.

The address of the principle office is: 855 South Federal Highway, Suite 203; Boca Raton, Florida 33432.

The mailing address of the corporation is: 855 South Federal Highway, Suite 203; Boca Raton, Florida 33432.

PURPOSE:

The general purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under Florida Chapter 607.

3) <u>AUTHORIZES SHARES:</u>

The aggregate number of shares that the corporation shall have the authority to issue is ONE THOUSAND (1000) shares of Capital Stock, all of one class. All such shares are with value of ONE DOLLAR (\$1.00) per share.

6) PREEMPTIVE RIGHTS:

Each shareholder of this corporation shall have the first right to purchase shares and securities convertible into shares, of any class, kind or series or stock in this corporation that may from time to time be issued, whether or not presently authorized, including shares from the treasury of the corporation, in the ratio that the number of shares he/she holds at the time issue bears to the total number of shares outstanding, exclusive of treasury shares. This right shall be deemed waived by any shareholders who does not exercise it and pay the shares preempted within thirty (30) days of receipt of notice from the corporation.

7) <u>CUMULATIVE VOTING</u>:

All or a designated voting group of shareholders are entitled to cumulate their votes for directors; specifically, in any election of directors, each shareholder of record may cumulate his her shares and to give one candidate as many votes as the number of directors to be elected multiplied by the number of shares equals, or to distribute them on the same principle among as many candidates as he sees fit.

8) BYLAWS

The power to adopt, after, amend or repeal by laws of corporation shall be vested in the shareholders by a majority vote of the shareholders of record.
