**ARTICLES OF INCORPORATION
OF
LOUIS SCOURTAS & ASSOCIATES , INC.**

ARTICLE I. CORPORATE NAME

The name of this Corporation is Louis Scourtas & Associates, Inc.

ARTICLE II. CORPORATE PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III NATURE OF BUSINESS

The general nature of the business to be transacted by this Corporation is to engage
in any and all business permitted under the laws of the State of Florida.

ARTICLE IV. CAPITAL STOCK

The maximum number of share of stock that this Corporation is authorized to issue
and have outstanding at any one time is 10,000 shares of common stock without par
value.

ARTICLE V. TERMS OF EXISTENCE

This Corporation shall have perpetual existence commencing upon these articles.
