ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is RAFF ENTERPRISES, INC.,

Article 2. Principal Office. The principal place of business and mailing address shall be 2140 - 10th Avenue, Vero Beach, FL 32960.

Article 3. Duration. The duration of the Corporation is perpetual.
