ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, herewith adopts the following articles for such corporation:

ARTICLE I

Name: The name of this corporation is: SUPER GLAZE SALONS, INC.

ARTICLE II

Duration: The period of its duration is perpetual.

ARTICLE III

Purpose: The purpose is to engage in any activities or business permitted under the laws of the United States of America and the State of Florida.

ARTICLE IV

Capital Stock: The corporation is authorized to issue 1000 shares, all of one class, at \$ 1.00 Par Value.

ARTICLE V

Address: The initial mailing address, which is also the address of the initial principal office of this corporation is: 8693 - 4 Street - North, St. Petersburg, FL 33702.

ARTICLE VI

Initial Registered Office and Agent Address: The street address of the initial registered office and registered agent of this corporation is: 8693 - 4 Street - North, St. Petersburg, FL 33702. The name of the initial registered agent at that address is : Joseph Ollinger.

ARTICLE VII

Initial Board of Directors: This corporation shall have one director initially. The number of directors may be increased or decreased from time to time, but shall never be less than one. The name and address of the initial director is: Joseph Ollinger, 8693 - 4 Street - North, St. Petersburg, FL 33702.

ARTICLE VIII

Incorporator: The name and address of the incorporator of this corporation signing these articles is: Joseph Ollinger, 8693 - 4 Street - North, St. Petersburg, FL 33702.

ARTICLE IX

Bylaw Amendments: The power to adopt, alter, amend or repeal the bylaws of this corporation shall be vested in the Board of Directors and the Shareholders.

ARTICLE X

Indemnification: The corporation shall indemnify any officer or director, or any former officer or director to the fullest extent as permitted by law.

ARTICLE XI

Informal Action of Directors: If all of the directors severally or collectively consent in writing to any action taken by the corporation, and the writing evidencing such consent is filed with the secretary of the corporation, the action shall be as valid as though it had been authorized at a meeting of the Board of Directors.

ARTICLE XII

Amendments of Articles: This corporation reserves the right to amend or repeal any provisions contained in these articles or any amendment thereto, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE XIII

Preemptive Rights: Every shareholder, upon the sale for cash or otherwise, of any new stock of this corporation of the same kind, class or series as that which he already owns, shall have the right to purchase his pro rata share thereof at the same price at which it is offered to others.

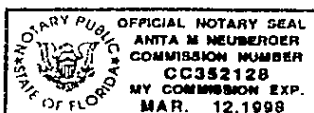
