ARTICLES OF INCORPORATION

OF

FLASH KURIER UND TRANSPORT, INC.

ENGLISH TRANSLATION: FLASH COURIER AND TRANSPORT, INC.

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE ONE

The name of the corporation is: FLASH KURIER UND TRNSPORT, INC.

The principle address of the corporation is: 3546 Ruskin Avenue,

Boynton Beach, Florida 33436.

ARTICLE TWO

This corporation shall commence its existence upon filing and shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE THREE
