ARTICLES OF INCORPORATION

OF

WESTERN LAKE DEVELOPMENT COMPANY, INC.

EFFECTIVE DATE

JUN - 9 1995

Article I - Name

The name of this corporation is Western Lake Development Company, Inc. The initial street address of the principal office and mailing address is P.O. Box 2096, Santa Rosa Beach, Florida, 32459.

Article II - Duration

This corporation shall exist perpetually, commencing with the date of execution and acknowledgment of these Articles.

Article III - Purpose

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of the United States and Florida.

Article IV - Capital Stock

This corporation is authorized to issue 7500 shares of One Dollar (\$1.00) par value common stock.

Article V - Initial Registered Office and Agent

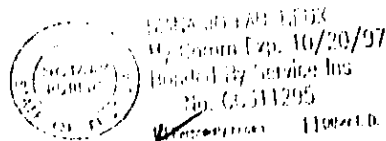
