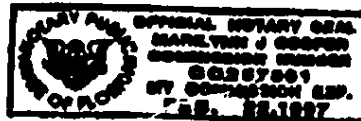

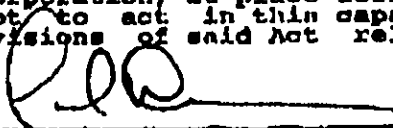

- 2) That the shareholders have directed the undersigned as incorporator to amend the Articles of Incorporation, Article Six to now read as follows:

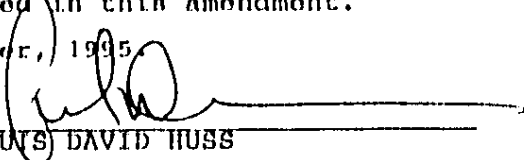

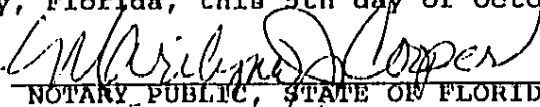
