We realize your mail is important to you and you have every right to expect it to be delivered intact and in good condition. The Postal Service makes every effort to properly handle the mail entrusted to us but unfortunately occasional damage may occur.

In order to process and deliver the mail in a timely manner, it necessary for us to use high-speed automated mail processing equipment. Occasionally this equipment malfunctions, causing damage to a few pieces of mail. Damage may also occur if bulky contents are enclosed in letter size envelopes or if the envelopes used are not secured properly. This causes the machines to malfunction and often causes damage to other mail that was properly prepared.

We are very concerned with reports of damaged mail and are doing everything possible to eliminate such incidents. We regret any inconvenience you have experienced as a result of this incident.
