The enclosed was found loose in the mails or has been damaged during the processing of the mail.

We realize your mail is Important to you and you have every right to expect it to be delivered intact and in good condition. The Postal Service makes every effort to properly handle the mail entrusted to us but unfortunately occasional damage may occur.

In order to process and deliver the mail in a timely manner, it necessary for us to use highspeed cutemated mail processing equipment.
